Arbitration is a procedure in which a dispute is submitted, by agreement of the parties, to one or more arbitrators who make a binding decision on the dispute. In choosing arbitration, the parties opt for a **private dispute resolution** procedure instead of going to court.

The decision reached can also be legally binding if the parties agree to make it so. PrivateCourt's decision is often final and binding, which means that the parties cannot appeal the decision or take the matter to court.

Is Private Dispute Settlement confidential?

In rules, an Arbitrator may be prohibited from disclosing any information related to the dispute. Parties can agree to confidentiality provisions in their dispute resolution agreement. PrivateCourt holds a high degree of confidentiality in all its proceedings.

Many countries have signed and ratified international agreements, such as the New York Convention and Geneva Convention on the Recognition and Enforcement of Foreign Arbitral Awards, which provides a framework for the arbitration awards across borders.


Why & How


What is Dispute Resolution Agreement




